Eligibility Criteria

- Be a Subject-Matter Expert in the desired field of instruction.
- Have at least 5 years of active experience at the operational level in the subject to be taught in the civil aviation authority organization.
- Have an extensive knowledge of the Convention on International Civil Aviation (Chicago Convention) and ICAO Standards and Recommended Practices and associated guidance material related to the desired field of instruction.
- Have excellent reading, writing, listening and speaking skills in English used for delivery of courses.
- Candidate must have successfully completed the instructor training course from Civil Aviation Training Center/Academy; ICAO certified institutions or Government recognized training organization.

Remarks: If the "Instructor Training course" completed by a candidate already exceeded two (2) years and he/she is not engaged in the delivery of training in CAA or, did not complete "Instructor Refresher Training Course" of five (5) days within the period of two (2) years, they are not eligible to participate in the program.

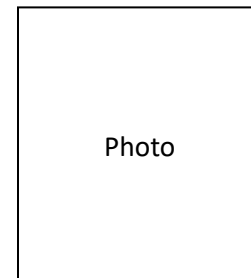
